These manikins are intended to be used as instructional aides in the teaching and demonstration of clearing an obstructed airway caused by a foreign body.

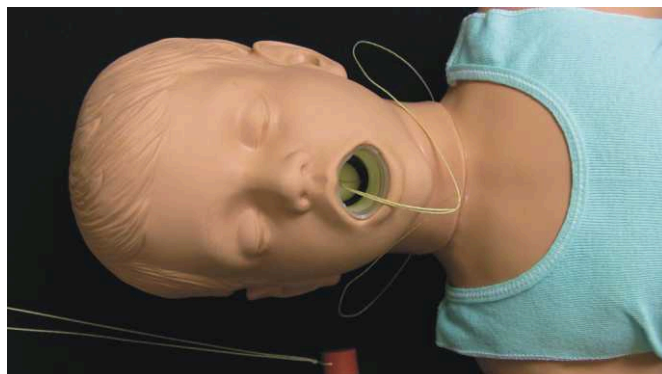
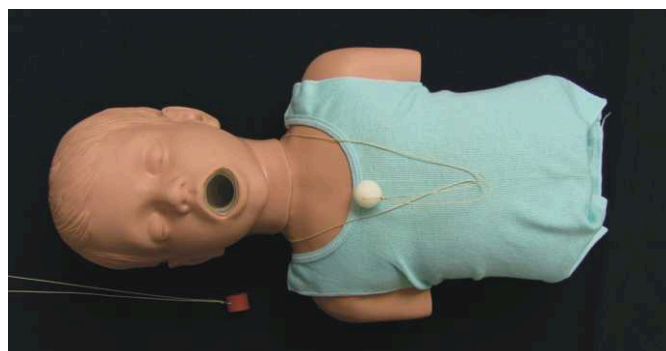
CHOKING MANIKINS

Simulaids Choking Manikins representing different age groups are designed for the practice of clearing an obstructed airway caused by a foreign body. Constructed of durable vinyl plastic, they include a rib cage, sternum and xiphoid process landmarks that show the appropriate hand placement areas for practicing the physical maneuvers necessary to dislodge objects. Abdominal or chest thrusts cause the expulsion of the obstruction. The Choking Manikins, except for the Infant Manikin number 1640, come with two objects; a round ball and a silicone cord representing a piece of meat. The Infant Manikin comes with a round ball.



Manikin Set Up

- Steps:**
1. Choose one of the choking objects to remain suspended around the neck of the manikin on the supplied string.
 2. Remove the other choking objects from the neck so it does not interfere and/or become entangled with the chosen object's movement.
 3. Place the chosen choking object into the manikin's mouth.
 4. Use a finger to gently push the choking object down into the back of the airway so it is positioned at the bottom of the airway passage.



Manikin Function

The manikin should only be used to practice obstructed airway maneuvers.

A properly delivered thrust with sufficient force will dislodge the choking object. Once the object is dislodged from the base of the airway passage, it may be necessary to turn the manikin face down and apply more thrusts to remove the choking object from the manikin's mouth.

Care and Maintenance

WARNING: Do not practice rescue breathing this can cause biological cross-contamination. There is no way to decontaminate the airway without damaging the manikin's interior. Manikin replacement will be necessary if rescue breathing is applied.

NOTE: Do not allow water to enter the mouth; it can accumulate in the interior foam and damage the manikin. Use a damp cloth to wipe off the manikin and then dry it before storing it. Use water soluble cleaners to remove dirt and grime from the exterior surfaces.

The carry bag included with your manikin is a top quality, colorfast nylon. Occasionally, manikin surfaces will pick up a trace of color from the bag. This will NOT affect the use of your manikin or your carry bag.

CAUTION: Do not wrap or store the manikin with printed paper, including the instruction booklet unless it is stored in a separate plastic bag. The manikin can be stained with ink and the ink cannot be removed. There is no warranty coverage for ink stains.
